**A. Authorization for Emergency Medical Treatment of a Minor**

- I also understand the club advisor will have made every appropriate attempt to contact me/us prior to acting on my/our behalf.
- This permission is granted only for the Summer 2005 U-19 Season and is further limited in scope to the season of the club in which my son/daughter is competing.
- NOTE: no student will be allowed to participate who can not assure the CHS Rugby Club Summer 7s League that s/he has medical coverage.
- This document shall be presented to a physician, dentist, or appropriate health care representative at such time as unexpected medical, dental, surgical care or hospitalization may be required.

The Student agrees to abide by these rules, regulations, policies and standards of behavior, and in all instances to follow the specific instructions of the CHS Rugby Club Summer 7s League coaches. Student and Parent/Guardian acknowledge and understand that the possession or use of alcohol or illegal and/or unauthorized drugs is forbidden.

Any infractions of the rules will result in the loss of CHS Rugby Club Summer 7s League privileges for the remainder of the school year, as well as other consequences, **including, but not limited to, exclusion from further participation in practices and games AND forfeiture of all dues paid for the season in which any infraction occurred. In the unlikely event of a permanent or temporary suspension from the CHS Rugby Club Summer 7s League, the Student and Parent/Guardian will be granted due process.**

## C. Parental Permission and Liability

The Parent/Guardian grants permission for the Student to participate in the CHS Rugby Club Summer 7s League. Although the activities of the CHS Rugby Club Summer 7s League will be coached and supervised by adults, it is agreed and understood that neither the Buffalo Public Schools nor any individual coach will suffer any liability. The Buffalo Public Schools and the coaches of the CHS Rugby Club Summer 7s League are hereby released from any liability, whether or not caused by fault or negligence, for any bodily injury, loss, theft or property damage sustained by the Student while participating in the CHS Rugby Club Summer 7s League. The Parent/Guardian and Student assume the inherent risks associated with contact sports, specifically as they occur during practices, scrimmages, clinics and/or games associated with the CHS Rugby Club Summer 7s League.

## Buffalo City Honors Rugby Club Girl's Summer 7s League

- A. Recreational Facility Form:** A *Buffalo Olmsted Parks Conservancy Recreational Facility Use Request Form* must be completed and submitted to the Conservancy at least six weeks prior to the proposed date of play.
- B. Payment of fees/security deposit:** Fees (stated on the reverse side of this form) must be paid via check, money order, VISA or MasterCard within 10 days of the start of the sports season or event to the **Buffalo Olmsted Parks Conservancy**, Parkside Lodge, 84 Parkside Avenue, Buffalo, NY 14214 or FAX to (716) 835-1300, Attention: SK
- C. Advertising:** No permit holder, nor his/her/their representative or associates, may post advertisements for their activities in any Buffalo Olmsted park via flyers, posters, banners, or by any other means in or on park property.
- D. Clean-up:** Permit holders are directly responsible for clean-up immediately following their events.
- E. Conduct/Behavior:** Disorderly conduct, rowdiness, or unreasonably loud noise or music is prohibited.
- F. Field Condition:** Fields/diamonds may be used only when weather and field conditions warrant, as determined by Conservancy officials. No play is allowed before May 1, after heavy rains or before sufficient upkeep and maintenance is performed. Only Conservancy staff may prepare, maintain or care for recreation facilities.
- G. Field Use:** Fields may be reserved for games only. Teams may practice on fields as available when no games are scheduled.
- H. Fire Arms:** Carrying or discharging firearms is prohibited.
- I. Hours:** Parks are open from sunrise to 10:00 p.m. unless permission is obtained from the Conservancy to extend access thereafter.
- J. Insurance:** \$1 million liability insurance coverage is required. The certificate must list the City of Buffalo, Erie County, and the Buffalo Olmsted Parks Conservancy as additional insured.
- K. Orders of Police and Park Officials:** Park patrons must comply with the lawful orders of police officers and park officials, and obey all general park rules and regulations.
- L. Parking:** Driving or parking on the grass or in play areas is prohibited. Parking is allowed in designated areas only. Illegally parked vehicles will be towed.
- M. Park Property:** Removal, destruction or defacement of park property or equipment is prohibited. Violators will be prosecuted.
- N. Alcohol/Drugs:** Illegal drugs and paraphernalia, alcoholic beverages, and glass containers are not allowed in the parks.

**I have read and agree to abide by the above rules and regulations. I understand that any failure to comply will result in denial of future permit requests and forfeiture of the required security deposit.**
